LOCATION

Lowestoft is located on the A47, 10 miles south of Great Yarmouth and 20 miles south east of Norwich and has a resident population of 75,000 which grows significantly in the summer months.

The property occupies a prime retail location adjacent to Boots and in the immediate vicinity of major national multiple retailers including **Marks & Spencer, Burton, Vodafone, Greggs and Barclays Bank.**

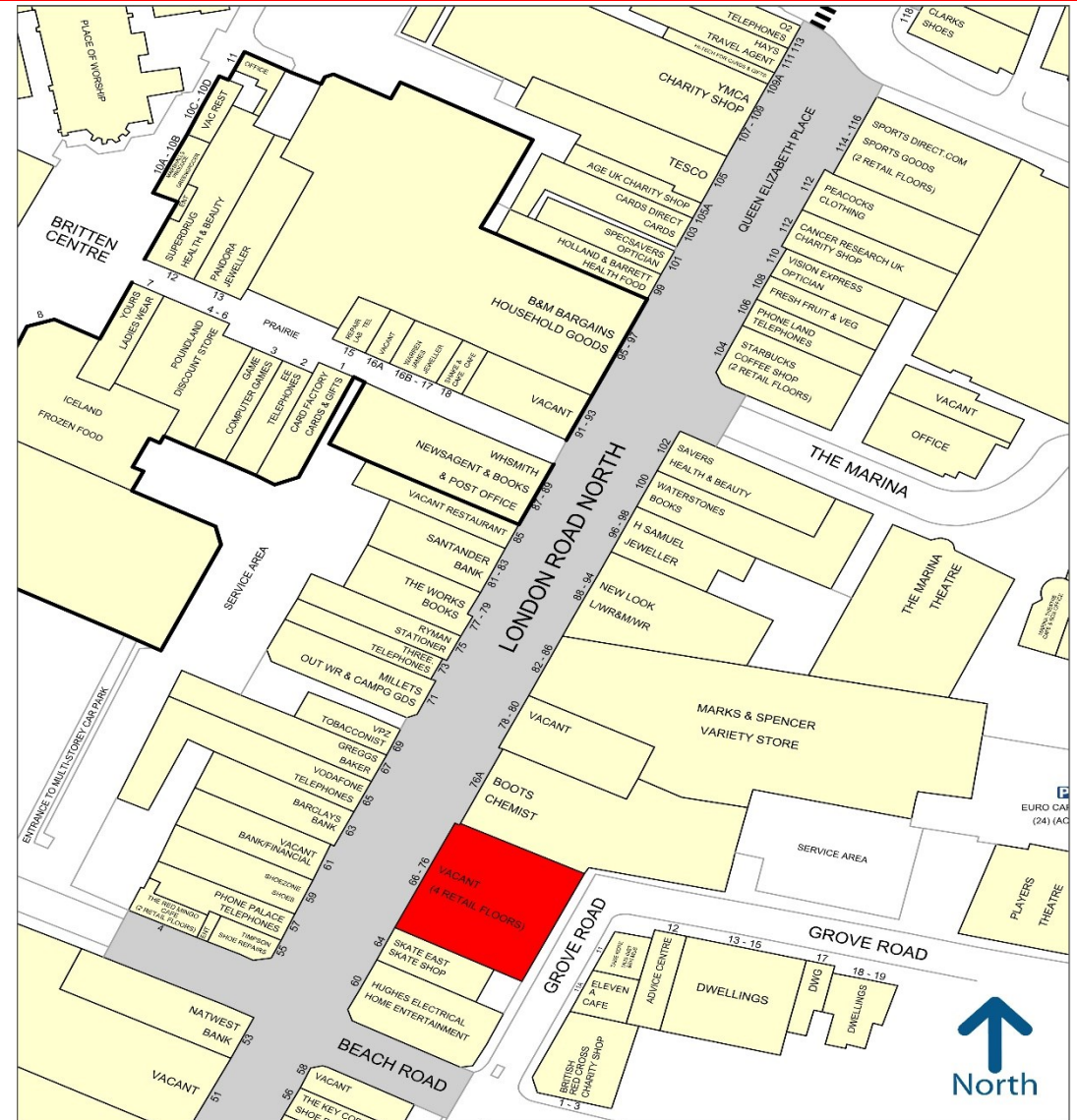
