LOCATION

Great Yarmouth is a major coastal resort 20 miles east of Norwich and 55 miles north-east of Ipswich.

The resident population of the Borough is 99,370 residents and is predicted to increase to 104,900 by 2041 (Source Great Yarmouth Borough Council).

In addition to the vibrant tourist industry, Great Yarmouth is the base for much of the southern North Sea oil and gas support services.

The property occupies a central position on Great Yarmouth's Golden Mile, surrounded by tourist and leisure attractions and well placed to benefit from the town's 6 million tourist visits each year.

ACCOMMODATION

The property comprises a purpose-built leisure complex including food and drink units and tourist attractions at ground floor, bars, restaurants and night clubs at first and second floors and the famous former ballroom.

Above the leisure venue complex is a former hotel on four floors with an additional floor of car parking. Three floors of the hotel has been partially converted to 18 flats. The fourth floor is currently disused.

PLANNING

We recommend that interested parties make their own enquiries of Great Yarmouth Borough Council Planning Department.

We understand that planning permission was granted in 2017 for conversion to 18 flats over 3 floors of the former hotel.

RESIDENTIAL

Three floors of the former hotel have been partially converted to flats, with each floor potentially providing three 1 bed flats and three 2 bed flats. Works on one floor are nearing completion whilst the other two floors are effectively at "first fix" stage. A currently disused fourth floor has potential for further residential conversion (subject to planning).
